



Driver Trainer and Rider Trainer Accreditation Application

Transport Operations (Road Use Management) Act 1995

This form may be used by you to apply for:

- Driver Trainer or Rider Trainer Accreditation
- renewal of a Driver Trainer or Rider Trainer Accreditation
- change existing class/es of vehicle you wish to give training for.

If you are applying for the grant of an accreditation as a Rider Trainer, you must already be an accredited Driver Trainer and be authorised to train a class R motorbike.

An accredited Rider Trainer may only give Q-RIDE training as a registered service provider or an employee of a registered service provider.

To apply for accreditation you must:

- (a) hold and have held for a continuous period of at least one year on the day the application is made an open Australian or New Zealand driver licence for the class of vehicle for which you propose to give training
- (b) pay appropriate fee
- (c) provide evidence of appropriate training.

Please note: Applications may be lodged prior to completion of the relevant training qualifications to allow the Department of Transport and Main Roads (TMR) to commence the required checks. However the relevant training qualifications must be lodged within three months from the lodgement of the application or the application will lapse and you will not receive a full refund of the application fee.

Additional Information

This application and fee must be lodged in person at a TMR Customer Service Centre or QGAP Office.

Upon approval of your application, you can use an Interim Industry Authority as evidence that you are authorised to perform the role until your industry authority card arrives in the mail. To obtain your interim industry authority by email ask to sign up for the TMR's e-reminders when submitting your application. For more information on e-reminders please refer to www.qld.gov.au/transport/enotice.

If you have an existing industry authority card, you must bring this with you.

If your accreditation has lapsed by three months or more from the expiry date, then you must re-apply and meet new application requirements.

Fees are not refundable if the application is unsuccessful.
