- · To be approved as a nominee you must have completed the Approved Inspection Station (AIS) core module.

 TMR will not accept criminal history check reports issued directly to the applicant by the Queensland Police Service or from a third party service provider.
- If a criminal history check fee is required, it must be paid before you lodge your application. The criminal history check fee can be paid at a TMR transport and motoring service centre or Queensland Government Agent Program (QGAP) office.
