



# Operator Accreditation Fees on Application

The table below sets out the Operator Accreditation (OA) fees as at 1 July 2018. The fees are subject to change annually.

To obtain full OA, applicants must successfully complete the OA Training Workbook available from the Department of Transport and Main Roads, or alternatively hold an equivalent qualification that is recognised by the department. For more information on OA training refer to information bulletin *PT211 Operator Accreditation Training* (which is located at [tmr.qld.gov.au/information\\_bulletins](http://tmr.qld.gov.au/information_bulletins)).

Applicants who do not meet the training requirement may be issued with provisional OA for three months and are required to pay the 'Provisional Application Fee'. The operator is then required to successfully complete the OA Training Workbook within the three month period.

Full OA can be issued from one to five years, in multiples of one year periods. If you would like to obtain OA for more than one year the fee will be the 'Full Application Fee' multiplied by the number of years the OA is being applied for. If applying for more than one category of OA, only the highest OA fee is payable.

The department undertakes criminal history checks on all applicants listed on the application that do not hold current driver authorisation. Criminal history checks are \$43.95 per person.

Where indicated, the number of vehicles refers to the maximum number of vehicles used at any one time to provide that service category.
