



Replacement Marine Licence Indicator/ Marine Licence Indicator Receipt/Address Label Application

Transport Operations (Marine Safety) Act 1994 (TOMSA)

This form may be used if you are applying for a replacement marine licence indicator for any of the following reasons:

- your marine licence indicator is damaged, destroyed, lost, stolen or smartcard has expired
- your marine licence indicator was not received in the mail
- your marine licence indicator is defective or faulty
- you have agreed to the amendment of your marine licence
- you have been granted a stay of the decision to cancel your marine licence by the Queensland Civil and Administrative Tribunal (QCAT)
- you have lodged an appeal against a court conviction but not against the severity of the sentence.

You may also use this form if you are applying for a replacement of your marine licence indicator receipt or address label if the receipt or label is damaged, lost or stolen.

Additional information

If you still have your marine licence indicator, you are required to present the indicator to the Department of Transport and Main Roads (TMR) at the time of this application. You are not eligible to make this application if your marine licence is cancelled or while you are disqualified from holding or obtaining a Queensland (Qld) marine licence.

If your marine licence is suspended, the code will not be shown on your marine licence indicator. You may apply to have the code included on your marine licence indicator when the suspension has ended.

Evidence of Identity (EOI) Requirements

You must give evidence of your identity. You may do so by showing your Qld driver licence, industry authority, marine licence indicator (conditions apply), Adult Proof of Age (APA) Card or Photo Identification (Photo ID) Card. All cards must be current or expired by less than two years.

If you are unable to show one of the above you will need to present three other acceptable EOI documents.

If you have changed your name or the details of your name are different on the documents provided, you must show a change of name document from the relevant Australian Register of Births, Deaths and Marriages (BDM).
