Transport Operations (Passenger Transport) Act 1994 Transport Operations (Road Use Management) Act 1995

Please note:

- This form must be completed by the registered operator of the motor vehicle to be stated in a booked hire service licence, if the booked hire service licence applicant is not the registered operator of the vehicle
- The Transport Operations (Passenger Transport) Act deems the registered operator of a vehicle used to provide a booked hire service, to be a person in the chain of responsibility
- If, at any time, the vehicle does not comply with the requirements for a booked hire service licence, the licence may be immediately suspended. As the registered operator, you should immediately notify the booked hire service licence holder of any changes to the vehicle's registration during the period of the licence.
- The booked hire service licence applicant must submit this completed form with their new application or licence amendment application.
