

# Special Interest Vehicle Registration Concession Application

*Transport Operations (Road Use Management) Act 1995 (TORUM)*

- This form must be completed and signed by one registered operator that holds current membership with an incorporated car club or association or an incorporated historical society or a current member of either an incorporated Fire Brigade Historical Society or incorporated Ambulance Service Historical Society.
- The SIV Guide sets out conditions imposed by the Department of Transport and Main Roads (TMR) under section 230(3) of the *Transport Operations (Road Use Management – Vehicle Registration) Regulation 2021*.
- Registered operators or anyone driving a concessionally registered SIV should be familiar with the conditions of use. Use of a vehicle outside of the conditions, may result in a fine or the concession being withdrawn.
- Evidence of identity (EOI), such as a Queensland Driver Licence, must be provided at the time of lodgement. For more information, go to [qld.gov.au/EvidenceOfIdentity](http://qld.gov.au/EvidenceOfIdentity).
- You can lodge your completed application and supporting documentation at a TMR customer service centre or, if you live in a rural area, a QGAP office, Magistrates Court or local police station that provides vehicle registration services.
- The compulsory third party (CTP) insurance class that applies to vehicles with a SIV concession is class 5. Registered vehicles will be changed by TMR to class 5 when the concession is applied. For details on CTP vehicle classes, go to [maic.qld.gov.au](http://maic.qld.gov.au).

## 5. Eligibility requirements

- ☐ Certificate of membership with an incorporated historical society or a certificate of Incorporation as an historical society with a recognised interest in vehicle heritage.
- ☐ **Historic vehicles** – Certification from a dating officer/club official of the vehicle's authenticity and year of manufacturer on club letterhead or official club documentation

**Note:** This is only required if the date of manufacture cannot be verified by TMR (from an existing or previous vehicle record, import papers, or manufacturer's plate)

- ☐ **Street rods and hot rods** – Certification from the Australian Street Rod Federation (ASRF) that the applicant is a current ASRF member and the vehicle was manufactured before 1949 or is a replica of a vehicle manufactured before 1949 on ASRF letterhead or official ASRF documentation.

## 6. Certification

I agree to inform TMR of any changes that may affect my eligibility to retain the concession within 14 days.

I acknowledge that the concession I am applying for is subject to conditions and agree to only use the vehicle in accordance with the conditions of the concession. For conditions, refer to the SIV guide located at [qld.gov.au/specialinterestrego](http://qld.gov.au/specialinterestrego).

I understand that if a vehicle on a concession is operated outside of the conditions of the concession, a fine may be issued, the concession may be withdrawn, and the full registration fee may become payable.

I consent to TMR verifying my EOI documents or information with the issuing authority or their agencies. I certify that the information and statements provided in this application are true and correct.
