

Special Interest Vehicle Registration Concession Application

Transport Operations (Road Use Management) Act 1995 (TORUM)

- This form must be completed and signed by one registered operator that holds current membership with an incorporated car club or association or an incorporated historical society or a current member of either an incorporated Fire Brigade Historical Society or incorporated Ambulance Service Historical Society.
- The SIV Guide sets out conditions imposed by the Department of Transport and Main Roads (TMR) under section 230(3) of the *Transport Operations (Road Use Management Vehicle Registration) Regulation 2021.*
- Registered operators or anyone driving a concessionally registered SIV should be familiar with the conditions of use. Use of a vehicle outside of the conditions, may result in a fine or the concession being withdrawn.
- Evidence of identity (EOI), such as a Queensland Driver Licence, must be provided at the time of lodgement. For more

- You can lodge your completed application and supporting documentation at a TMR customer service centre or, if you live in a rural area, a QGAP office, Magistrates Court or local police station that provides vehicle registration services.
- The compulsory third party (CTP) insurance class that applies to vehicles with a SIV concession is class 5. Registered
 vehicles will be changed by TMR to class 5 when the concession is applied. For details on CTP vehicle classes, go to
