Please note

- This form does not apply to Domestic Commercial Vessels (vessels which are used in connection with commercial, governmental or research activities).
- A Recreational Ship is a ship used only for private recreational purposes.
- A ship that is used for purposes other than recreation (such as school activities, surf lifesaving or other community activities) is called an Other Queensland Regulated Ship.
- An Other Queensland Regulated Ship that is 6 metres or more in length or designed to carry more than 12 persons or operating more than 15 nautical miles (nm) from land is called a Prescribed Other Queensland Regulated Ship.
- All ships with a motor of 3kW and over (over 4hp) must be registered.
- A fee is payable with this application, unless exempt.
- It is in your interest to ensure ship identifiers are taken from the ship (not paperwork or previous registration).
- An Australian Builders Plate is required on ships built and offered for sale after 28 September 2006.
- The owner/master of a ship must not operate a ship unless the ship is safe. A ship is safe if it is seaworthy and is appropriately equipped and crewed, to meet the ordinary perils of the voyage on which the ship is proceeding or about to proceed.
- Obligations under the *Petroleum and Gas (Safety) Regulation 2018* and the *Electrical Safety Act 2002* must be met.

You will also need

- Personal Identification e.g. Queensland Driver Licence or suitable business/company/organisation identification. Refer to the separate *Evidence of Identity Information Sheet* (F4362) or www.tmr.qld.gov.au for requirements.
- Proof of origin of the ship (this may be a *Bill of Sale*; receipt from an auction; beneficiary of estate; etc.) if the Department of Transport and Main Roads (TMR) has no record of previous registration.
- Recreational ships that are 15 metres or more in length will require an endorsement from Maritime Operations (Maritime.Operations@msq.qld.gov.au) prior to registration.
- Prescribed Other Queensland Regulated Ships will require an endorsement from Maritime Operations (Maritime.Operations@msq.qld.gov.au) prior to registration.
