



- This form must be completed and signed by the registered operator (Sharer) and the nominated primary producer (Borrower).
- Both parties must have a TMR Customer Reference Number (CRN). If not, you must complete the New Customer Application and present the form and supporting documentation in person to your nearest transport and motoring customer service centre or, if you live in a rural area, a QGAP office, Magistrate Court or local police station that provides vehicle registration services.
- The Sharer and the Borrower must be a recognised primary producer. Both parties must have a Primary Producer qualification with TMR and provide proof via a tax agent declaration.
- For first applications only, a Primary Producer Concession/Qualification Application (F5381) must be lodged in person at your nearest transport and motoring customer service centre or, if you live in a rural area, a QGAP office, Magistrate Court or local police station that provides vehicle registration services by both the sharer and borrower before this application can be lodged for processing. To check qualification eligibility, contact TMR on 132380.
- For each restricted primary production vehicle, no more than five other primary producers (each of whom must be a recognised primary producer) can be nominated to use the vehicle.
- The eligible vehicle/s must only be used by recognised primary producers in connection with their primary production business.
- The vehicle must not be advertised or arranged for hire, or be hired.
- This form must be completed for each nominated primary producer (Sharer and Borrower).
