

# **Prior Driving Experience Application**

Transport Operations (Road Use Management) Act 1995 (TORUM)

#### Important information

This form may be used if you wish to apply for the recognition of prior driving experience to enable you to meet the 100 hours supervised driving experience requirement for the grant of a Queensland provisional licence, and you hold, or have held -

- an interstate learner licence that corresponds to a Queensland class C learner licence
- a New Zealand learner licence that corresponds to a Queensland class C learner licence
- a learner licence granted under the law of a recognised country, that corresponds to a Queensland class C learner licence.

#### Accredited driver trainer

You may apply to have a maximum of 10 hours of supervised driving experience with an accredited driver trainer credited to a total of 30 hours (that is, 1:3 ratio). Record your total hours (to a maximum 30 hours) with an accredited driver trainer at Q4.

Additional hours with an accredited driver trainer should be recorded in either daytime or night fields.

#### Supporting documents

You will need to give documentary evidence of prior driving experience hours to support your application, for example, an interstate/overseas learner logbook that corresponds with a Queensland learner logbook, driver trainer receipts or correspondence.

If the documents you give do not show sufficient details about your driving experience, such as: dates; vehicle registration numbers; distances travelled; driving time in minutes; names of supervisors, you must attach a separate sheet giving these details.

Your supervising driver is required to complete Section 2. However, this section is not required to be completed if the details of your driving experience in your interstate/overseas learner logbook have been verified and signed by your supervising driver/s. If you have had more than one supervising driver that has not verified your supporting documents, you will need to lodge additional Prior Driving Experience Application form/s completed by each supervising driver.

#### Interstate or New Zealand learner licence holders

If you hold a learner licence from another Australian state or territory, or New Zealand, you may apply for credit for up to 100 hours supervised driving experience gained on Australian or New Zealand roads.

#### Foreign learner licence holders (recognised countries only)

If you hold a learner licence from one of the recognised countries listed at www.qld.gov.au/transport, you may apply for credit for up to 50 hours supervised driving experience gained on roads from that country. However, you will need to complete the remaining 50 hours on Australian roads and record those details in a Queensland learner logbook. Please attach your logbook with this application.

When to lodge this application and supporting documents You must lodge this application and supporting documents once you have completed 100 hours supervised driving experience.

How to lodge this application and supporting documents If you have a Queensland learner logbook, you must lodge this application together with your logbook and other supporting documents at your nearest Australia Post outlet at least 12 business days prior to your Q-SAFE practical driving test.

If you are applying for credit of supervised driving experience without a Queensland learner logbook, you must lodge this application together with your supporting documents by registered mail to: Customer Service Operations, Department of Transport and Main Roads, GPO Box 5232, BRISBANE QLD 4001 at least 12 business days prior to your Q-SAFE practical driving test.

Lodgement of this application does not guarantee that you will automatically be eligible to take your practical driving test to be granted a P1 provisional licence.

If the information given by you in this application is incomplete or the Department of Transport and Main Roads (TMR) is not satisfied that you have completed 100 hours supervised driving experience, you will be required to complete a Queensland learner logbook. You will be

notified as soon as your Prior Driving Experience Application has been assessed.
