

Authority to Check a Visa Holder's Work Entitlement

Under the *Transport Operations* (*Passenger Transport*) Regulation 2018, when a person makes application for a driver authorisation or to renew their driver authorisation, they must provide evidence of their entitlement to work in Australia.

If you hold a current passport (foreign) and visa with an entitlement to work in Australia you must present your passport and record the passport number and place of issue on this form.

If you hold an alternative Australian issued travel document or an ImmiCard you must present it.

The Department of Transport and Main Roads will use the Department of Home Affairs (DHA) Visa Entitlement Verification Online system to verify your work entitlement.

Note: The department cannot accept your application until your work entitlement has been verified.
