- parked on private property when a contract is in place with the property owner.

To apply for a Tow Truck Operator Accreditation

- Complete the application form and lodge it in person at a Department of Transport and Main Roads (TMR) customer service centre or QGAP office
- Provide Evidence of Identity (EOI) documentation for the applicant and each person listed on the application. Information about EOI for individuals/organisations is available at www.tmr.qld.gov.au (search evidence of identity)
- · Pay the required fees
- After you lodge this form a TMR Transport Inspector will contact you to arrange inspection of the business premises, holding yards and tow trucks.

The applicant name/s on the form must have a Customer Reference Number (CRN). If the applicant does not have a CRN, complete a *New Customer Application (Individual)* (form F3503) or *New Customer Application (Organisation)* (form F5379).

 Holding yards to be authorised on the Tow Truck Operator Accreditation A holding yard is used to store vehicles and movable property resulting from crash towing, police seizure towing or towing from private property and must be listed on the tow truck operator accreditation approval document. To be authorised, a holding yard must have: a structurally sound fence or wall, that is at least 2.1m high (from the ground) or a barrier sufficient to prevent unauthorised entry and lockable gates and doors or another barrier sufficient to prevent unauthorised persons from entering the premises and the unauthorised removal of motor vehicles and property from the premises. A TTOA holder must stop using an authorised holding yard immediately, if it no longer complies with the above requirements. The letter must state that, as the owner/lease holder of the holding yard, they understand their responsibility for the ongoing compliance of the holding yard as per the requirements under the Tow Truck Act including: ensuring the fences, barriers, gates and doors are kept closed and locked unless a person or vehicle is passing through repairing any damage to the fences, barriers, gates and doors within a reasonable timeframe, even if the damage is caused by another tow truck operator accreditation holder preventing unauthorised persons from entering or exiting the premises preventing the unauthorised removal of vehicles and movable property from the premises. Tow truck vehicles listed on a Tow Truck Operator Accreditation

Vehicles that provide crash towing, police seizure towing or towing from private property must be listed on the accreditation. An authorised tow truck must have markings on both sides of the tow truck that display the:

- business name, business address and telephone number of the operator
- classification of the tow truck
- tow truck identification number (issued by TMR).

7. Vehicle details

All vehicles used for crash, police seizure or private property towing must be listed below. Vehicles must be Qld registered. All vehicles being removed from the accreditation must have the four digit number issued by TMR removed.

If a vehicle is not registered to the applicant, the registered operator must sign in the box to authorise TMR to access the vehicle details information.

In making this application, I agree to TMR carrying out those enquiries it deems necessary to determine if I meet the suitability requirements for a TTOA. I give my consent for TMR to conduct such enquiries during the period of my accreditation to assess my ongoing suitability to hold the TTOA. Such enquiries include, but are not limited to:

- a national Criminal History Check (charges including those yet to be determined, convictions and certain investigative and disciplinary information) through the Queensland Police Service (QPS) and a New Zealand criminal history check through New Zealand Police, if required. I authorise the release of information by QPS, the Australian Police Services and New Zealand Police to TMR.
- enquiries with the courts, police, prosecuting authorities or other such relevant bodies or entities necessary to enable TMR
 to make a full and informed assessment of my suitability for a TTOA. I authorise TMR to use this information to maintain a
 database which is used to prepare correspondence, monitor transactions and to provide other government agencies with
 information relating to my TTOA. I give consent to TMR taking, keeping and using personal information for the issue of a
 TTOA under the Tow Truck Act, *Transport Operations (Road Use Management) Act 1995* or otherwise authorised by law.
