A community service concession can only be granted to an organisation established for the purpose of providing help to persons in distress. Help includes care, relief, support, housing, education or instruction.					
Persons in distress is defined as any person in distress as a result of:					
<ul> <li>death or disability of another person on whom they were wholly or partly dependent</li> <li>disease, sickness, age, physical or mental infirmity, destitution, unemployment</li> </ul>					
fire, flood, cyclone, drought, war or other emergency or catastrophe.
