6. Certification

I acknowledge that the concession I am applying for is subject to the above conditions, including the restricted use of the vehicle or requirement for the vehicle to continue being garaged in a designated restricted area, and agree to only use/garage the vehicle in accordance with the conditions of the concession.

I understand that if a vehicle on a concession is operated outside of the conditions of the concession, a penalty infringement notice may be issued, the concession may be revoked, and the full registration fee may become payable.

I consent to TMR verifying my EOI documents or information with the issuing authority or their agencies.
