



# Removal of Absolute Disqualification for Unlicensed Driving Application

Transport Operations (Road Use Management) Act 1995

Please use this form if you are applying for the removal of an absolute disqualification for a conviction for unlicensed driving.

You are only eligible to make application for the removal of an absolute disqualification if:

- a. you were disqualified absolutely from holding or obtaining a driver licence for the offence of unlicensed driving before 13 March 2002
- b. when you were disqualified absolutely for the unlicensed driving offence, you were not convicted and disqualified absolutely, at the same time as any other offence  
For example - If you were convicted for an unlicensed driving offence at the same time you are not eligible to make this application.
- c. you have not had an earlier application for the removal of your absolute disqualification refused by a court or the Department of Transport and Main Roads (the department) within the past 12 months.

### Additional Information

The lodgement of this application does not guarantee it will be approved. Your traffic history will be considered. Your application cannot be considered at the time of lodgement. It must be forwarded for consideration. You must complete this application form and forward to the department:
