- Class 22 Compulsory Third Party (CTP) insurance is required to cover the period of the journey. See details in question 5 of this form. Trailers are not required to obtain CTP insurance.
- Evidence of identity or business/company/organisation identification is required (for example, Queensland/ interstate driver licence, Medicare card or Australian Company Number (ACN) certificate). For more information, visit www.qld.gov.au/evidenceofidentity.
- Permits are calculated on the number of calendar days required and a fee is charged for each day the permit is issued.
- Where a permit is purchased and no longer required, a refund may be given for the unused portion. The refund will be calculated from the day after the permit is returned until the expiry date. The cost of the first day is non-refundable.

Conditions under which a permit may be issued

- A permit may be issued to tow or drive an unregistered vehicle from Point A to Point B by the shortest possible route in the shortest possible time (minimum period one day, maximum period seven days).
- The driver of the unregistered vehicle or the driver of the vehicle towing an unregistered trailer must carry the permit and present it on demand to an authorised person.

A permit will not be issued if the vehicle:

- is not in a safe condition and would not pass, or has failed, a safety inspection
- has number plates, including personalised or customised plates, attached
- is being moved to Queensland from interstate. A permit must be purchased from the state or territory where the journey starts
- does not have a Vehicle Identification Number (VIN) or chassis number (an engine number may be used if the vehicle is manufactured before 1930)
- is subject to a serious unresolved vehicle manufacturer defect recall (e.g. Takata airbag recall)
- is currently under a Number Plate Confiscation Notice issued by the Queensland Police Service
- is left-hand drive and under 25 years old
- · is left-hand drive and weighs 4.5 tonnes or more
- is being used to carry a load for hire or reward, to take rubbish to the dump or to use a vehicle for an event such as a wedding or a formal
- is modified (e.g. a specially constructed vehicle or stock car)
- is written-off and needs to be moved (this includes to get a written-off vehicle inspection)
- is an imported vehicle that is not yet certified as a compliant vehicle
- · is only eligible for conditional registration
- exceeds mass and dimension limits for road use (unless operating under a relevant guideline or has been issued a permit).
