

## Change of Customer Details (Organisation)

Transport Operations (Marine Safety) Act 1994 (TOMSA); Transport Operations (Road Use Management) Act 1995 (TORUM); Tow Truck Act 2023

This form may be used to change the name, address, or other details of a Company, Business, Trusteeship, Organisation or Authority that have been given to the Department of Transport and Main Roads (TMR). These changes will be recorded automatically against every motor vehicle (including trailer), tow truck and recreational ship registration. Please provide evidence of the organisation's identity (e.g. Certificate of Incorporation).

If changing the type of organisation, you are considered a new customer and must complete the New Customer Application (Individual) (F3503).

For changes to the Business/Company/Organisation name or **number** both the previous and new identification is needed. For example, if a company name changes, both the previous and new Certificate of Incorporation must be provided.

For changes to an operator accreditation that was issued under the Transport Operations (Passenger Transport) Act 1994. you must also complete the Operator Accreditation Change/ Replacement (F3208).

If transferring a motor vehicle registration, you must use the Vehicle Registration Transfer Application (F3520). If transferring a recreational ship registration, use the Queensland Regulated Ship Registration Transfer Application (F3521).
