

# Personalised Number Plate/s Application – Euro/ Colour/Themed/Prestige and Traditional



Transport Operations (Road Use Management) Act 1995 (TORUM)

## **Conditions of Issue and Use**

- 1. You acknowledge that the issue of personalised number plates comprising your chosen combination of characters does not preclude the Department of Transport and Main Roads (TMR) from issuing a substantially similar combination, provided it is not wholly identical.
- 2. The applicant must produce acceptable Evidence of Identity (EOI) when the application is lodged. (For requirements, refer to the separate *Evidence of Identity Requirements for Individuals Information Sheet* (S5385) or *Evidence of Identity Requirements for Organisations Information Sheet* (S5386) or www.tmr.qld.gov.au).
- 3. If plate/s are being purchased as a gift, the plate/s will be recorded in the name of the purchaser and the person receiving the plates as a gift must complete a *Personalised Number Plate/s Transfer Application* (F2963), and lodge this with TMR on receipt. of the plate/s.
- 4. Payment is required at the time of the application for personalised number plate/s to be accepted.
- 5. Before removing and/or attaching any number plates to or from a vehicle, you must advise TMR by lodging a *Remove and/* or *Attach Personalised/Customised Number Plate/s Application* (F2964). This also applies to plates given by way of a gift. If the vehicle currently has standard issue number plates attached, these plates must be surrendered when applying to attach personalised number plates.
- 6. Personalised number plates cannot be attached to a vehicle currently under a Number Plate Confiscation Notice issued by the Queensland Police Service.
- 7. If you need to replace/remake personalised number plates, a fee may be payable.
- 8. If you transfer the ownership of your personalised number plates, a transfer fee may be payable.
- 9. Vehicles using LPG must refrain from obtaining plates with a red background.
- **10.** Motorcycles and trailers will only have one number plate manufactured. This plate can only be attached to the rear of the motorcycle or trailer.
- 11. Traditional Q plates If the applicant has existing Q plates, they must have been traditionalised whilst still on an active registration to be valid. If the registration has lapsed, the applicant must reapply for the combination if available. Traditional plate/s can be attached to motor vehicles and large trailers. Only one plate will be manufactured for a large trailer. Motor vehicles must have one plate attached to the front and one plate attached to the rear of the vehicle. No plate number above 687612 will be issued as a traditional plate. All other rules relating to personalised number plates apply to Q plates once they are issued as traditional number plates. Please call PPQ on 136 356 for further information.
- **12.** TMR does not approve the use of number plate covers (excepting those issued by PPQ for prestige plates). Use of some covers may reduce visibility, usable life or warranty, and may result in fines and penalties.
