Transport Operations (Road Use Management) Act 1995 (TORUM)

- Evidence of identity (EOI), such as a Queensland (Qld) Driver Licence, must be provided at the time of lodgement. For more information, go to qld.gov.au/EvidenceOfldentity.
- You can present the form and concession card or supporting letter in person to your nearest Department of Transport and Main Roads (TMR) customer service centre or, if you live in a rural area, a QGAP office, Magistrate Court or local police station that provide vehicle registration services.
