# **Notification of Driver Licence Enforcement Option - Nomination**



Transport Operations (Road Use Management) Act 1995

You may only use this form to notify the Department of Transport and Main Roads (the department) in person of your chosen option if you have received an *Accumulation of Demerit Points Notice to Choose* (form F4011) or a *Courtesy Notice - Your Licence Option Choice* (form F4010).

You can also notify the department of your choice using the department's online service (Notify Demerit Point Enforcement Choice) at www.tmr.qld.gov.au. To use this service you will need your Notice Number, which is located at the top left corner on the front page of either your *Accumulation of Demerit Points Notice to Choose* (form F4011) or your *Courtesy Notice - Your Licence Option Choice* (form F4010). Please note, the online service may not always be available 24 hours a day, 7 days a week.

## 1. Your choice of option

- You may choose either the driver licence suspension for the stated period or a good driving behaviour (GDB) period for one year.
- To be eligible to choose a GDB period you must hold a valid Queensland driver licence. That is, your driver licence must not be expired, cancelled or suspended for any reason, and you must not be disqualified by order of an Australian court from holding or obtaining a driver licence. You will not be able to choose a GDB period if you do not hold a valid Queensland driver licence. For example if your driver licence is suspended for a speeding offence or unpaid fines, or you have been disqualified by an Australian court.
- Consider your options carefully as once you notify the department of your choice, and your driver licence suspension period or GDB period is accepted by the department, it is final and cannot be changed.
- If you fail to notify the department of your choice on or before your choice date, your Queensland driver licence will be suspended from the day after your choice date.

## 2. When your choice of option will start

- You must notify the department of your choice of option and the start date, on or before your choice date. Your choice date is stated on your *Accumulation of Demerit Points Notice to Choose* (form F4011) and on the *Courtesy Notice Your Licence Option Choice* (form F4010).
- Your start date may be earlier than your choice date, but it cannot be before the current date or after your choice date. If you choose a start date after the current date (that is, a date in the future), your eligibility for your choice will also be validated on that date. For example if you choose a GDB period to start one week from the current date, you will also need to hold a valid Queensland driver licence on your nominated start date.

## 3. How to notify the department of your choice

Present this form and the accompanying notice in person at a Department of Transport and Main Roads customer service centre. Please go to www.tmr.qld.gov.au for a full list of customer service centres.
