

# High-Powered Vehicle Restriction Exemption Application (Individual)

Transport Operations (Road Use Management) Act 1995 (TORUM)

Use this form if you are applying for an exemption to allow you to drive a High-Powered Vehicle (HPV).

For vehicles manufactured on or after 1 January 2010 a HPV is a car that has:

- a power-to-weight ratio of more than 130kW/tonne
- an engine that has been modified or replaced in accordance with modification codes LA1, LA2, LA3 or LA4 of the Queensland Road Vehicle Modification Handbook (the QRVMH). Further information can be found on the *Certificate of Exemption for Driving High-Powered Vehicle Information Sheet* (form S4478).

For vehicles manufactured before 1 January 2010 a HPV is a car that has:

- eight or more cylinders
- a supercharged or turbocharged engine, not diesel powered
- an engine that has a power output of more than 210kW under the manufacturer's specifications for the car
- a rotary engine with an engine capacity of more than 1146cc under the manufacturer's specifications for the car
- an engine modification requiring approval under section 17 of the VSS Regulation.

# **Exemption categories**

## Personal circumstance grounds

You may be eligible for an exemption to drive a HPV if you can prove that the only car reasonably available is a HPV, that you need to drive:

- to or from your place of employment
- · as part of your employment
- · to or from an educational institution that you attend
- to get medical treatment for yourself or a member of your immediate family.

You must also demonstrate that:

- · no other transport is reasonably available
- refusal to grant an exemption would cause severe hardship to you, or your family because you have taken on a role of special responsibility in relation to your family.

## Supporting statement

Your application must be supported by a signed statement on letterhead from your employer, the person in charge of your educational institution, your doctor or your immediate family member's doctor, that confirms your circumstances and details the days and times and why you need to drive a HPV.

## Vehicle ownership grounds

You may be eligible for an exemption to drive a HPV if you can prove that the only car reasonably available is a HPV that:

- if manufactured before 1 January 2010, was owned by you on 30 June 2007 and you still own it
- if manufactured on or after 1 January 2010, was owned by you on 1 January 2014 and you still own it
- · is owned or leased by an immediate family member
- is in the possession of an immediate family member provided under an employment or salary package.

You must demonstrate that:

- · no other transport is reasonably available
- refusal to grant an exemption would cause severe hardship to you, or your family because you have taken on a role of special responsibility in relation to your family.

Your application must be supported by either:

- evidence you owned the car on the stated date and still own it
- evidence your immediate family member owns, leases or possesses the car under an employment or salary package.

#### Supporting statement

Your application must include a signed statement from your immediate family member that confirms your circumstances and details the days and times and why you need to drive a HPV.

### Moderately-powered vehicle grounds

You may be eligible for a certificate of exemption if the car you wish to drive was manufactured before 1 January 2010 and has:

- a supercharged or turbocharged engine, not diesel powered
- · a power-to-weight ratio of not more than 125kW/tonne
- no other features of a HPV listed on this form.

Your application must be supported by either:

- a document published by the manufacturer, such as the owner's manual or information from the manufacturer's website verifying the vehicle's kerb weight (the weight of an empty vehicle with a full tank of fuel, without any accessories), maximum engine power or the calculated 'power-to-weight ratio'
- a specification information test report issued by an automotive service provider.
- A specification information test report must include all of the following:
- the name and address of the organisation(s) that conducted the test(s)
- the date of the test(s)
- the vehicle make, model, year of manufacture, VIN/chassis number and engine number
- the vehicle's kerb weight and maximum engine power
- details about the measuring system used to conduct the test, for example, an engine dynamometer.

**Note:** As maximum engine power is required to assess your application, results from a roller dynamometer/chassis dynamometer (which test the power after it has been dispersed to the axle) will not be accepted.

## Additional information

The lodgement of an application does not guarantee it will be approved. Your application cannot be considered at the time of lodgement. It must be forwarded for assessment which may include consideration of your traffic history. You will be advised of the outcome within 28 days.
