

Alcohol Ignition Interlock Program - Interlock Exemption Change of Circumstances Declaration

Transport Operations (Road Use Management) Act 1995 (TORUM)

This form is to be used if you hold a current Alcohol Ignition Interlock Program interlock exemption and you are notifying the Department of Transport and Main Roads (TMR) of a change to your circumstances.

It is important to note that if the change to your circumstances affects the ground on which you were granted the exemption, outlined on your interlock exemption approval letter as a relevant change, then your interlock exemption will cease to have effect 14 days after you notify TMR. For example, if you were granted an interlock exemption because your residential address met the remote location exemption criteria and you move house, then your exemption will cease to have effect 14 days after you notify TMR that you had moved.

Failing to notify TMR, in writing, of a relevant change of circumstances within 14 days is an offence and may incur a penalty of more than \$3200.

If the change to your circumstances is not relevant to the ground on which you were granted the exemption, then the change will be assessed by TMR and, if the restrictions applying to the exemption have changed, an amended exemption certificate may be issued.

1. Medical condition

If you were granted an interlock exemption on the basis that you have a medical condition that prevents you from providing a sufficient breath sample to operate an approved interlock - you must notify TMR if there is relevant change to your medical condition. For example, your medical condition may improve such that you are able to provide a sufficient breath sample to operate an approved interlock.

Note: If you are advising of a change to your medical condition, other than an improvement that allows you to provide a sufficient breath sample, you must provide supporting documentation from your doctor.

2. Reside in a remote location

If you were granted an interlock exemption on the basis that you live in a remote location - you must notify TMR if your residential address changes.

3. Reside on an island

If you were granted an interlock exemption on the basis that you live on an island - you must notify TMR if your residential address changes.

4. Severe hardship

- A. If you were granted an interlock exemption on the basis that it is not physically possible to fit an approved interlock to the only vehicle reasonably available, no other transport is reasonably available, and refusal to grant the exemption would cause you or your family member severe hardship you must notify TMR if:
 - a vehicle that an approved interlock may be fitted to becomes available
 - other transport becomes available to you or your family member.
- B. If you were granted an interlock exemption on the basis that a member of your family has a medical condition that prevents them from providing a sufficient breath sample to operate an approved interlock, there is only one vehicle reasonably available, no other transport is reasonably available, and refusal to grant the exemption would cause you severe hardship you must notify TMR if:
 - there is a relevant change to your family member's medical condition
 - another vehicle becomes available for you or your family member to drive
 - other transport becomes available to you or your family
- C. If you were granted an interlock exemption on the basis that refusing to grant an exemption would cause you severe hardship, other than by preventing you from driving in relation to your employment or education you must notify TMR if any of the circumstances that contributed to that situation change.

D. If you were granted an interlock exemption on the basis that refusing to grant an exemption would cause your family member severe hardship, **other than** by preventing you from driving them to or from work or an educational institution - you must notify TMR if any of the circumstances that contributed to that situation change.
