

## **Primary Producer Concession/Qualification Application** *Transport Operations (Road Use Management) Act* 1995 (TORUM)

- This application must be lodged in person at your nearest transport and motoring customer service centre or, if you live in a rural area, a QGAP office, Magistrate Court or local police station that provides vehicle registration services.
- This form must be completed and signed by the registered operator.
- Evidence of identity (EOI), such as a Queensland Driver Licence, must be provided at the time of lodgement.
- This form is used to apply for a Primary Producer qualification and/or concession on an eligible heavy vehicle. The concession is available for vehicles that are used by primary producers and co-operative associations involved in the business of primary production.
- A primary producer is a person whose business consists mainly of the production of primary produce. Any transportation of primary produce is incidental.
