



# Farm Plate Concession Application

Transport Operations (Road Use Management) Act 1995 (TORUM)

- This form must be completed and signed by the registered operator.
- Evidence of identity (EOI), such as a Queensland Driver Licence, must be provided at the time of lodgement.
- Farm plates are issued for vehicles used only by primary producers in their business as a primary producer. A primary producer is a person who carries on a business in which the main activity is the production of primary produce. Transportation of the primary produce must be incidental only.
- The vehicle can only be used to travel between different parcels of land managed by the primary producer.
- The travelling distance is restricted to the maximum distance allowable as in the 'Heavy vehicle zone maps: Queensland' available at [www.qld.gov.au/transport](http://www.qld.gov.au/transport).
- Motorbikes and conditionally registered vehicles are not eligible for a Farm Plate concession.
