## 2. Evidence of identity

You must attach a photo of your Queensland driver licence, Photo ID Card/Adult Proof of Age Card or other TMR card that shows your customer reference number (CRN).

We need to see the front and back of your card, and your CRN must be clearly shown.

You must attach a colour photo that is:

- Digital (jpeg format) >
- Taken from a 1.5m distance (between you and the person taking the photo) Note: The photo must not be a selfie. >
- Passport quality >
- Recent (taken within the last six months) >
- > Not edited (for example, by removing spots or red eye, softening lines, any sort of filter or fish-eye lens)
- Taken with a plain, light coloured background (for example white, cream or light grey) >
- > Taken without glasses or sunglasses, even if you wear them for driving.
